Good afternoon,

Thank you for submitting your expression of interest for your child to attend Farnborough Road Infant School in our 3 year old nursery.

We understand that some parents may have been hoping for their children to be enrolled in January 2025 or April 2025; unfortunately, due to our current availability we will be unable to make any new enrolments until **September 2025**.

We will of course keep your child’s application on file and contact you should anything become available sooner.

Looking ahead to **September 2025**, we would like to try to get an idea what your preferences for days and hours may be.

Children aged 3 and 4 are entitled to 15 free hours of childcare per week from the term after they turn 3. We split our school week into beginning of the week (Monday, Tuesday & Wednesday AM) and end of the week (Wednesday PM, Thursday & Friday) sessions.

Some children may be eligible for up to 30 hours of free childcare per week depending on individual circumstances. A 30 hour place is equivalent to a full time space in our main nursery from 8.50am – 3.10pm, Monday – Friday (term time only).

If you are not eligible for a 30 hour code, then you are still able to pay to top up your child’s nursery sessions beyond their 15 hours should you wish to do so. The cost of a full additional day from September 2025 will be £45.00.
